## **Position Announcement**

### **Dean of the College of Law National Chengchi University**

Applications and nominations are invited for the position of the Dean of the College of Law, National Chengchi University, Taipei, Taiwan. The Dean is the chief academic and administrative officer for the College and reports to the President. The position is available as of August 1, 2019. The initial term is for 2 years with a renewable second term.

From 1946 to 1993, the College of Law was essentially comprised of all sister disciplines in social sciences, including political science, diplomacy, economics, sociology, public finance, and law. In 1993, in order to recognize and highlight the differences between social sciences and jurisprudential study, the College of Social Sciences was separately founded to include all departments except the department of law, which alone constitutes the College of Law.

After the above reorganization, the College of Law, in view of the trend of highly specialized studies in legal education and curricular in German, Japan, and the United States, set up six specialized research centers on the top of a single department of general legal education. These six centers include the Center for Civil Law, the Center for Criminal Law, the Center for Public Law, the Center for Economic and Financial Law, the Center for Fundamental Jurisprudence, and the Center for Labor and Social Law. The then blossom model of one department and multiple institutes and research centers was applied to structuring the College of Law.

In 2003, to keep up with the trend of life-long learning and to enhance the law education for other professionals, the Master of Laws Program for Executives was launched. Furthermore, in order to meet the demands of an increasingly pluralistic society as well as to cultivate various professionals requiring the interdisciplinary integration with legal education, the Institute of Law and Inter-discipline (ILI) was established in 2004, which mainly admits students of non-law majors and is focused on the integration between law and various professional fields.

The final candidate, to be determined by the President, needs to be a full professor of NCCU or, if not, needs to be recruited as a full professor by NCCU before his/her inauguration of the Dean.
